Sub: Go-live of the EPR Portal for ELVs for Registration of Producers and Registered Vehicle Scrapping Facilities (RVSFs) – reg.

Sir/Madam,

This is in reference to the Environment Protection (End-of-Life Vehicles) Rules, 2025 under Environment (Protection) Act, 1986, notified on 6th January, 2025 for implementation of Extended Producer Responsibility (EPR) Regime on End-of-Life Vehicles (ELVs). The said rules came into force from 1st April, 2025, to regulate the management, recycling and disposal of ELVs in an environmentally sustainable manner (Copy enclosed).

In this regard, CPCB has developed the EPR Portal for ELVs (<https://eprelv.cpcb.gov.in/>) as mandated under said Rules and launched the registration modules for Producers and RVSFs on 15.01.2026 through which Producers and RVSFs may submit applications for registration under the EPR-ELV framework.

As per the Rule 12(1) of said notification, the Central Board shall grant registration to Producers whereas the State Board shall grant registration to RVSFs and Bulk Consumers as per Rule 14(1).

In order to facilitate the processing and grant of registration to RVSFs, the list of authorized officials (Approving Officer and Recommending Officer) along with their contact details, who will be involved in the registration of RVSFs through the online portal, may be provided. Based on the information provided by SPCBs/PCCs, the login credentials for the said officers will be created by CPCB. The provision for creating login credentials of Reviewing Officer(s) by the respective State Board has been provided in portal.

In view of the above, it is requested to kindly ensure that the Producers and RVSFs operating within the respective jurisdictions are registered on the EPR-ELVs portal at the earliest and also provide the aforementioned details of the authorized officials in the prescribed format provided at Annexure-I to eprelv.cpcb@gov.in within 07 days.
